The following changes have been revised as follows;

1. With effect from 15<sup>th</sup> September, 2021, policy extensions;

a) *Excess Protector &*

b) *Political Violence and Terrorism (PVT)* are excluded from the following PSV policies;

- PSV Unmarked (Chauffer Driven)
- PSV Taxi

The effective rate for New and renewals will therefore be

**Comprehensive Rate: 4.75% (*Exclusive of Excess Protector*)**  
**Add PLL@500 per passenger**

2. All Commercial vehicles proposed with PLL above 9 passengers, shall require a coloured photo of the vehicle and NTSA Verification at inception.
