

# Online media fuel divisions, global tensions - report

Reporters Without Borders say democratic societies increasingly fractured by social media disinformation

London, Tuesday

Unregulated online content has spread disinformation and propaganda that have amplified political divisions worldwide, fanned international tensions and even contributed to Russia's invasion of Ukraine, a media watchdog warned Tuesday.

Reporters Without Borders said democratic societies are increasingly fractured by social media spreading disinformation and more opinion media pursuing a so-called "Fox News model", referring to the controversial right-wing television network in the United States.

At the same time, despotic and autocratic regimes that tightly control information in their societies are using their "asymmetric" position to wage "propaganda wars" against democracies and fuel divisions within them, the watchdog said in the 2022 edition of its annual World Press Freedom Index.

"Polarisation on these two levels is fueling increased tension," Reporters Without Borders, widely known by its French acronym RSF, said in a five-page summary.

## Russia invasion of Ukraine

It noted Russia, where state-run media overwhelmingly dominate and independent outlets are increasingly stifled, invaded Ukraine following a propaganda war.

"The creation of media weaponry in authoritarian countries eliminates their citizens' right to information but is also linked to the rise in international tension, which can lead to the worst kind of wars,"

RSF Secretary-General Christophe Deloire said.

He added the "Fox News-isation" of Western media also poses a "fatal danger for democracies because it undermines the basis of civil harmony and tolerant public debate".

Deloire urged countries to adopt appropriate legal frameworks to protect democratic online information spaces.

Record 'very bad'

The situation is "very bad" in a record 28 countries, according to this year's ranking of 180 countries and regions based on the degree of freedom enjoyed by journalists.

The lowest ranked were North Korea (180th), Eritrea (179th) and Iran (178th), with Myanmar (176th) and China (175th) close behind.

Russia (155th) and ally Belarus (153rd) were also on its red list of the most repressive.

Hong Kong's position plummeted dozens of places to 148th, reflecting Beijing's efforts to use "its legislative arsenal to confine its population and cut it off from the rest of the world", RSF said.

Nordic countries Norway, Denmark and Sweden again topped the index, serving as a democratic models "where freedom of expression flourishes".

The NGO commended Moldova (40th) and Bulgaria (91st) this year due to government changes and "the hope it has brought for improvement in the situation for journalists".

But it noted "oligarchs still own or control the media" in both.

Media polarisation was "feeding and reinforcing internal social divisions in democratic societies" such as the United States (42nd).

That trend was even starker in "illiberal democracies" such as Poland (66th), a European Union country where suppression of independent media was also noted by RSF. The NGO, launched in 1985 and which

has published the yearly index since 2002, has become a thorn in the side of autocratic and despotic regimes around the world.

This year's listing was developed with a new methodology redefining press freedom and using five new indicators -- political context, legal framework, economic context, sociocultural context, and security -- to reflect its "complexity".

## Ugandan journalists in trouble

In Kampala, journalists in Uganda often face rough treatment at the hands of security forces, which soared during the 2021 election, marred by the worst bloodshed in years.

The East African country has seen a series of crackdowns on those opposed to President Yoweri Museveni's rule, particularly around last year's election, with journalists attacked, lawyers jailed, vote monitors prosecuted and opposition leaders violently muzzled.

The rights situation in Uganda has also been highlighted by the case of an award-winning author and outspoken government critic, Kakwenza Rukirabashajja, who was charged with insulting President Yoweri Museveni.

Last February, the novelist fled to Germany to seek medical treatment out of fear for his life after being tortured, according to his lawyer. Kakwenza Rukirabashajja

was arrested shortly after Christmas and charged with "offensive communication" in a case that raised international concern.

The charges against him relate to unflattering comments on Twitter about Museveni, who has ruled Uganda since 1986, and his powerful son Muhoozi Kainerugaba.

The author was awarded the 2021 PEN Pinter Prize for an International Writer of Courage, which is presented annually to a writer who has been persecuted for speaking out about their beliefs. Rukirabashajja has been repeatedly arrested since the publication of "The Greedy Barbarian", which describes high-level corruption in a fictional country.

Ugandan activist Norman Tumuhimbise was then arrested on March 10 alongside Farida Bikobere, who works with him at online media platform DigitalTalk TV, on charges of cyber-stalking the country's president.

Both were released on bail on March 21. The duo were among nine journalists arrested for offensive communication under the Computer Misuse Act which can carry a one-year prison sentence and/or a fine.

Seven were released without being charged.

Tumuhimbise, who heads local pressure group The Alternative Movement, was to launch a book critical of President Yoweri Museveni on March 30.

## Turkana UDA parliamentary aspirants resolve to bury the hatchet

Two UDA aspirants for Turkana Central seat have agreed to work together after a hotly contested nomination exercise that threatened to split the party members in the constituency.

Joseph Namwar and Festus Lorogoi agreed to bury the hatchet and work together to secure the seat currently occupied by UDA county gubernatorial candidate John Lodepe.

Namwar was declared the winner

but Lorogoi felt the nominations were not free and fair and threatened to vie as an independent candidate.

There were complaints that both camps had damaged each other's reputation so much in the campaign trail that it seemed that it was almost impossible to reconcile the two factions.

UDA Lodwar Township Ward candidate Ruth Kuya took the bull by its horns and challenged the two to shake

hands in a church service yesterday.

The two shook hands but agreed that a committee with representation from both camps would sit and agree on how the two teams would campaign for UDA.

So vicious was the fight that the spouse of Governor Joshat Nanok, Margaret could not hide her joy after the duo shook hands.

"Indeed we have seen the working of God, the disunity between the two

was almost denying us the Turkana Central seat," she said.

UDA gubernatorial candidate John Lodepe said the unity of the two camps would now enable the county team to focus on winning the seats instead of fighting amongst themselves.

Lodepe will face former Petroleum and Mining CS John Munyes of Jubilee party and Loima MP Jeremiah Lomurukai of ODM in the August polls.

# Kalonzo throws spanner in hunt for Raila deputy

Wiper Party to withdraw its representative from selection panel, says its leader will not be vetted

Wiper Democratic Movement (WDM) party headed by former Vice-President Kalonzo Musyoka has engaged top gear in its quest to land the number two position in Azimio La Umoja-One Kenya Alliance.

It says it has suspended campaigns for the the Azimio presidential candidate Raila Odinga until it gets the slot. The announcement, coming on the eve of the day a panel selected to vet short-listed running-mate candidates begins its work, will ruffle feathers. Instructively, the deadline for presidential aspirants to submit the names of their running-mates is May 16, hardly two weeks away.

To ensure former Vice-President Kalonzo Musyoka is handed the slot, his allies say they will pull their representative from the panel and that Kalonzo will not undergo vetting.

Yesterday, Kalonzo's allies indicated that Kitui Senator Enoch Wambua would not be in the selection panel that is set to start interviewing candidates today.

In what signals a hardening of positions, Suna East MP Junet Mohammed, who is Azimio's Executive Committee Secretary General, yesterday said that failure to appear before the selection panel would be deemed as withdrawal from the contest.

## Demeaning interview

Makueni MP Daniel Maanzo confirmed that Wiper Party has put on hold campaigns for Raila until the issue of the running mate is conclusively "made in our favour".

Even as the selection panel begins its work tomorrow, Kalonzo's troops have threatened to ensure that their leader does not appear before it for any interview as that would be demeaning.

Instead, the foot soldiers of the former Foreign Affairs minister want the seven-member selection panel dissolved and Kalonzo directly nominated by Raila as his running-mate in the August 9 General Election.

"Our stand remains the same. That no

Kalonzo, no votes for Raila. We have also advised Kalonzo not to appear before the panel because there is nothing about the former Vice-President that Raila does not know," Makueni MP Daniel Maanzo, a hardliner in the Wiper party, told the People Daily yesterday.

Maanzo added that the panel is a face-saving entity to hoodwink Kenyans that the exercise is transparent yet "the head-hunt is meant to rig out Kalonzo."

"If anyone is still thinking that Kalonzo will take up any other position other than that of Deputy President, he or she is day-dreaming. What matters at the moment are the two million votes that Raila will either get if he nominates Kalonzo, or will lose if he bypasses him," Maanzo said.

Yesterday, Kalonzo, as if reading from the same script said his experience, standing in society, and performance are written in white and black.

"Everything is plain, so why should we waste time? If [Raila] Odinga takes me, he will be the next President of Kenya. I am a sure bet; there is no need to waste time," he told People Daily. And last week, in an interview with a TV station, Kalonzo said it is obvious he is the best choice for running mate, adding that he should not be asked to apply for the position.

## Lose Ukambani votes

"If we were to tell each other the truth, and everyone in our team knows the right thing to do, I do not understand why anyone would ask me to apply for the position of running-mate. Did Raila apply to be the flag-bearer?" he posed.

He stated that should Raila fail to pick him as the running-mate, he (Raila) would suffer a big blow as he would lose the majority of votes from Ukambani.

The seven-member panel comprises Ms Elizabeth Meyo, Bishop Peter Njenga, Archbishop (Rtd) Zaccheus Okoth, Kitui Senator

Enoch Wambua, Narc Kenya Secretary General Michael Orwa, former Cabinet minister Noah Wekesa, Council of Imams and Preachers of Kenya Organising Secretary Sheikh Mohamed Khalifa and Ms Beatrice Askul Moe from Turkana County. An itinerary of the panel indicates that members are to converge at Serena Hotel at 8am today. They will then be driven to an undisclosed venue.

The agenda of today's meeting, according to the itinerary, is to set the terms of reference, agree on the deadline, elect the chairman, secretary and other officials, and agree on the modalities and procedures of carrying out their mandate.

Though the panel has outlined the requisite qualifications, insiders in Azimio La Umoja-One Kenya Coalition say the position is likely to be given to a person from Mt Kenya region, with former Justice and Constitutional Affairs Minister Martha Karua, Health Cabinet Secretary Mutahi Kagwe and his Agriculture counterpart Peter Munya being the front runners.

While the Kalonzo camp has been pushing for him to be nominated, sources say some leaders in Azimio are not comfortable with the Wiper leader. They cite his continuous threats and intimidations, flip-flopping and a need to win the support of Mt Kenya region.

Those in support of Karua say she is firm against corruption, reformist-leaning, straight forward and authentic. Other qualities include a good working relationship with Raila and President Uhuru Kenyatta, as well as honesty and integrity.

But some allies of Uhuru are said to have misgivings on Karua for accommodating losers from Jubilee's nominations in her Narc Kenya outfit.

Accusations against her have also emerged that she isolated Jubilee honchos in Central Kenya in Raila's tour of Kirinyaga

on Sunday and Monday.

Those fronting for new entrant Kagwe say he is a reformist who is not afraid of daunting tasks, an example being the restructuring he launched at Kenya Medical Supplies Agency (Kemsas) and at National Hospital Insurance Fund (NHIF). Kagwe is also good at mobilisation of national and international support for critical areas, like he did in the fight against Covid-19.

Other names being mentioned for the position are former Gatanga MP Peter Kenneth, Nakuru Governor Lee Kinyanjui, Murang'a Woman Representative Sabina Chege, Mombasa Governor Hassan Joho and Kieni MP Kanini Kega.

## Inconsequential threats

Nyeri Town MP Ngunjiri Wambugu says the prerogative to choose the running mate lies with Raila and nobody should try to coerce him. "At the end of the day, the responsibility will remain in Raila's hands. So, all these threats, intimidations and lobbying are inconsequential. Nobody can force Raila to work with somebody he is not comfortable with," he says.

In a statement on Sunday, the panel outlined the qualifications for the candidates, that included fidelity to the Constitution, personal integrity in public and private life, objectivity and impartiality in decision making. The candidate should also shun nepotism, favouritism, improper motives and corruption. Other attributes include selfless service, public trust, honesty in execution of public duties and declaration of any personal interest that may conflict with public duties.

The statement signed by Ms Meyo said the panel has up to May 10, 2022, to finish its work and submit the shortlisted nominee to Raila for consideration. "Thereafter, the successful candidate shall be unveiled to the public by Raila," she said.

# Ngilu: I'm more suited than Wiper leader to deputise Azimio chief

Kitui Governor Charity Ngilu says she is the appropriate person to deputise Azimio La Umoja-One Kenya Alliance's presidential flagbearer Raila Odinga in the coming polls.

She adds that if the candidate will be picked from Ukambani, she is more suited than Wiper leader Kalonzo Musyoka.

For long, Ngilu has been uncomfortable with Kalonzo's stature in Ukambani. She spoke at twin rallies in the former Vice-President's Tseikuru and Katse home turfs in Kirinyaga North on Monday.

Flanked by MCAs Boniface Kilaa (Tseikuru) and Johnson Kanandu (Mumoni), the governor said she had high esteem for Kalonzo, "but he was not prolific and dependable".

## Stand to be counted

"When the time comes for Azimio to pick its running mate from Ukambani, I will stand to be counted. What do you, the people of Mwingi North and Kitui at large, think? Am I not able and fit?" she asked.

She said her history in politics goes back to 1997 when she became the first woman to vie for the presidency on a Social Democratic Party ticket.

"I fought alongside Raila in the



Opposition to remove Kanu's one-party tyrannical rule. I understand Raila very well," she said.

## Nothing to chance

The governor said Azimio La Umoja is not leaving anything to chance, adding that they were resolute in their quest to see Raila win.

She appealed to Kenyans to reject Deputy President William Ruto's candidature for the top seat.

During the tour, she commissioned Tseikuru town's 600-metre tarmac road, funded by her administration to ease transport and reduce respiratory diseases caused by dust.

She also issued 8,500 land title deeds to Mumoni residents and presented empowerment fund cheques to various youth, women and people living with disabilities in the sub-county.

She said: "It is a pleasure to fulfill the promise I made in 2019. Today, land owners will receive title deeds in line with President Uhuru Kenyatta's plan to legally settle Kenyans".

The governor added that registration of boda boda operators and issuance of smart driving licences would be rolled out soon, in conjunction with the Interior Ministry and National Transport and Safety Authority.

# Transition to secondary schools begins

Magoha assures that over a million candidates, who sat the 2021 KCPE exam will join secondary schools

Admissions for the 2021 Kenya Certificate of Primary Education (KCPE) examination candidates to the over 10,000 secondary schools will commence today.

Education Cabinet Secretary (CS) Prof George Magoha, has assured that the over 1 million candidates, who sat the exam will be admitted to secondary schools in line with the government's 100 per cent transition policy.

Last week, the ministry changed the opening date for Form Ones to May 4 occasioned by gazetting of May 3 as a public holiday.

## Economic times

"The Cabinet Secretary, Ministry of Interior has gazetted May 3 as a public holiday, which is the date the Form One students were expected to report. Consequently, it has been decided that the reporting date for Form One students will be from May 4," said the ministry in a circular dated April 27 to Regional and County Directors of Education.

The Form One candidates are joining a week after the rest of the classes resumed learning, even as the government insists that it will work with the local administra-

tion to ensure that all of them report to school.

The ministry has said it will work with other government agencies to ensure that no candidate misses a place in secondary school. Officials from the education ministry will be required to file accurate daily returns on the status of reporting to schools.

Parents/guardians and school managers are expected to facilitate smooth admission of all children to secondary schools.

Yesterday, some parents were in a last minute rush to prepare their children to report to their new secondary schools.

Parents have been complaining of exorbitant amounts charged by some schools for learners joining Form One, but are optimistic that all will run smoothly despite the harsh economic times

In most cases, the schools either referred the parents to select uniform distributors from where they are required to source the uniform for the new school entrants.

In other cases, the schools directed that the Form Ones would only buy the uniform at the school when they report.

The outraged parents took to social media platforms to register their disapproval of the move by the schools to charge as much as Sh30,000 for uniforms.

Some parents have however said that they have had to look for alternative uniform outlets.

"I looked at the list and prices provided by the school and felt it was beyond my reach, so I had to look for an alternative. We have made sure that the uniform has the appropriate shade and in the long run, I have saved at least Sh8,000 which will pay

part of the school fees instead," a parent whose child is joining Form One in a school in Nairobi said yesterday.

Already, the Ministry of Education has made a call to needy and vulnerable students joining Form One to apply for the Elimu scholarship.

## Vulnerable learners

Some 9,000 needy and vulnerable learners who scored 280 marks and above out of the possible 500 marks in the 2021 KCPE exams, are eligible to apply.

"Only candidates who sat KCPE from public primary schools in all 47 counties in the country are eligible to apply," the Ministry has said, in a public notice.

For affirmative action, candidates who are orphans and those with special needs and disabilities who attained below 280 marks may be considered.

Learners who also qualify are those whose parents are persons with disabilities, which compromises their ways of meeting financial obligations for their children and whose families are affected by HIV/Aids and other chronic illnesses with debilitating effects, that could render parents and guardians destitute thus unable to fend for their children.

The ministry has urged applicants to submit duly filled forms, including supporting documents by close of business this Friday.

# Raila taps into Uhuru campaign machine in Central

Azimio presidential candidate urges Jubilee candidates to actively market its candidature

Azimio la Umoja—One Kenya Alliance presidential candidate Raila Odinga has launched a charm offensive in the Mt Kenya region to consolidate votes ahead of the August elections.

Raila, who has never enjoyed the backing of the region since he first ran for the presidency in 1997, has put in place a strategy to tap into the Jubilee Party machinery that propelled President Uhuru Kenyatta to victory in the 2013 and 2017 elections.

In a series of meetings with leaders from the region who won in the recent Jubilee primaries, Raila is seeking to wrestle a chunk of the voters from the region seen to be currently supporting UDA presidential candidate William Ruto.

Yesterday, Raila appealed to those who clinched Jubilee tickets during the primaries and other Azimio affiliated parties that they should not be afraid to sell his candidature to the electorate and promised to accommodate those who lose in the August elections in his government.

"Do not be afraid to sell Raila to the electorate. We have come together to consolidate the votes in the larger Mt Kenya. All those aspiring as MCAs, National Assembly Members, Senators, Woman Representatives and Governors should not be afraid of selling Raila," he said.

## Bottom up

Raila urged the aspirants that the Azimio secretariat led by Raphael Tuju had formed committees from the Ward level all the way to the constituency and county levels and will be supported by the National Secretariat.

He asked aspirants in Kiambu county to be his foot soldiers.

"You are the link between the voters and me," said Raila.

He pledged that his administration would ensure that Kenya's economy is on

the right track.

The former Prime Minister accused Ruto of seeking to entrench poverty using his Bottom Up economic model.

"We will not just create jobs, but we will create meaningful jobs to our people and our youths. We do not just want to give jobs because jobs are jobs, we have the potential of creating meaningful jobs," said Raila.

While drumming up support for Raila during the meeting with Kiambu aspirants at Windsor Hotel in the county, Tuju said there was a reason Uhuru had decided to back the former premier for the top seat.

Tuju described Raila as a reformist and a champion of good governance while Ruto, he said, was only out to secure his own interests.

"I did not vote for Raila in 2017 but there is a reason why we are supporting his candidacy. He is a person who thinks about the country first and is not selfish. President Uhuru knows Ruto more than you know him and there is a reason why he is not supporting him," said Tuju.

## Single mothers

The Azimio Executive Director told the aspirants that Uhuru's administration had achieved more thanks to the support he received from Raila after the March 2018 Handshake.

Murang'a Woman Representative Sabina Chege, who is also a member of the Azimio Council, asked the gathering to back Raila's candidature.

She claimed that their opponents had looted public coffers and should not be trusted with the leadership of the country.

"Show me your friends and I will show you your character. If you look at those coalescing around him, almost all of them are tainted with corruption. Is that the team you want to place at leadership helm?" posed Chege.

Nyeri Deputy Governor Carol Karugu said that under a Raila's administration, women, single mothers and widows would benefit from a special social protection programme, adding that the aspirants should tell the electorate the truth about Azimio's manifesto.

"The programme will help single mothers. In fact Central Kenya has many single mothers. A social protection programme is

what we want. The Sh6,000 will help cushion the poor of the poorest in society," she said.

Former Gatanga MP Peter Kenneth said the politics of the country had changed, adding that Coast, North Eastern, Eastern, Nairobi, Samburu and Turkana all back Raila.

"I have accompanied Raila in many parts of the country and they are all backing his presidency. Where there is a problem is only Central. We also need to be in Raila's camp and ultimately in his government. Kiambu is the biggest county in Mt Kenya and once Kiambu delivers, Mount Kenya will have delivered," said Kenneth.

He said the campaign think-tanks were in the final stages of preparing a manifesto that would be given to the candidates to sensitise the electorate with.

# Sankok, wife questioned following son's death

The Directorate of Criminal Investigations (DCI) officers in Narok are carrying out investigations into the circumstances under which the son of Nominated MP David Sankok allegedly shot himself dead at the family home in Ewaso Ng'iro trading centre on Monday afternoon.

The team led by the County Criminal Investigations Officer Mwenda Ethaiba camped at the MP's home for the better part of yesterday seeking to know how the boy accessed the gun.

They interrogated the MP, his wife, daughter and workers.

Ethaiba said they are trying to establish what could have triggered the minor to shoot himself and what the MP told him during a Monday afternoon argument regarding his failure to report to school.

The officers are investigating how the 15-year-old son, a Form Three student, gained access of his father's bedroom where the shot gun was kept.

"We are also trying to establish what could have triggered the minor to shoot himself," he said.

The detectives recorded statements from workers at the MP's Osim Country Lodge which is about 100 metres from his home.

According to area Sub-County Police Commander Isaac Ogembo, the incident happened at 3:30pm on Monday.

The lawmaker is said to have sent his son pocket and shopping money ahead of the schools' reopening last week, but the boy disappeared from home only to resurface on Monday.

Upon his return, his father is said to have demanded to know why he was not in school, leading to an altercation.

Soon after, the MP reportedly left for the lodge and returned home after one hour only to find his son lying in a pool of blood with the shot gun next to his body. Nobody was in the house at the time of the incident, according to police.

The detectives are also carrying out forensic analysis on the body.

# Former Naivasha legislator goes independent after UDA dispute

Former Naivasha MP John Kihagi has declared he will seek to recapture the seat as an independent candidate after the United Democratic Alliance (UDA) overturned his win in the nominations.

This is after the party released a statement Monday saying incumbent Jayne Kihara will carry the UDA flag in the constituency in the election.

In a statement signed by the chair of the UDA Electoral Board Anthony Mwaura, the party defied an order by the Political Parties Tribunal to carry out repeat elections.

The board overturned Kihagi's controversial win and declared Kihara the winner in the nominations held on April 14, with 9,904 votes against Kihagi's 9,903 votes.

Kihagi then filed an appeal to the Political Parties Tribunal who ordered a repeat election. But on Monday, UDA defied the tribunal's verdict and confirmed Kihara as the candidate.

In a rejoinder, Kihagi said: "I have decided to submit to the Independent Electoral and Boundaries Commission (IEBC) my intention to vie as an independent candidate."

Joho said under a Raila government, the Coast region would reap big in development.


"We know how Raila works. He listens to advice. All we want is development," he said.

## NMS to spend Sh1.47b on pedestrian, cyclist lanes

Nairobi Metropolitan Services (NMS) is set to spend Sh1.47 billion to expand Non-Motorised Transport (NMT) within the capital.

The move seeks to create more walking spaces for pedestrians. It entails construction of pedestri-

an and cycling lanes and is expected to cover a total of 116 kilometres.

Project, which was first rolled out in the city centre, is being expanded in the estates with the aim of providing safety and decongesting the city.

"Non-Motorised Transport lanes (red for cyclists, grey for pedestrians) are currently being expanded in surrounding estates. The project

is expected to cover 116 kilometres," NMS Director-General Lt-Gen Mohammed Badi (pictured) said.

Already, the pedestrian and cycling lanes have been rolled out on Kenyatta Avenue, Wabera, and Muindi Mbingu Streets.

The grey and red lanes are currently being expanded beyond the CBD to Hurlingham, Uhuru Park,

Jogoo Road and Westlands.

"Through our contractors, we have created NMTs in the city centre and plans are already in place to extend it to other areas. We are now working on more along Jogoo road and Westlands," Badi said.

First phase will cover 36km, with NMT corridor spreading to Eastlands.

# Poll finds 53pc of city voters undecided as election nears

Aspirants for top seats must now work tooth and nail to promote their candidature in a bid to garner votes

With about three months to this year's General Election, 53 per cent of eligible voters in Nairobi are yet to decide on who to vote for, a new survey that was released yesterday has shown.

Consequently, aspirants for top seats in Nairobi may have to work harder to promote their candidature.

A survey by Trends and Insights for Africa (Tifa), which was conducted between April 26 and May 1, found that most of city residents were yet to make up their mind on who they want to be their next governor, senator and Woman Rep.

The leading presidential candidates; Azimio-One Kenya's Raila Odinga and his Kenya Kwanza counterpart Deputy President William Ruto will also have to pull up their socks to garner more votes in the city as almost half of the 649 respondents were yet to decide who they will vote for.

In the governor's race that has attracted firm interest from both Azimio and Kenya Kwanza, the poll indicates that the number of the undecided are more than half of the voters.

As per the Independent Electoral and Boundaries Commission, Nairobi has 2,505,199 registered voters for the August 9 elections.

Tifa's survey's approximates that 53 per cent of this number is yet to decide on who they want to be their governor, raising questions regarding the findings.

However, Azimio and Kenya Kwanza alliances did not pick their aspirants until towards the end of last month, that could explain why many voters are yet to pick their choices. Azimio has settled on Polycarp Igathe for the governor's seat while Kenya Kwanza has picked Senator John-



son Sakaja. From the poll, Sakaja, who is being fronted by Ruto's United Democratic Alliance, is the most preferred candidate although he had 23 per cent support, followed by Igathe of Jubilee, with 16 per cent.

### New faces

Another hopeful, Richard Ngatia, who has since dropped out of the race in favour of Igathe, came third with three per cent while Governor Anne Kananu got one per cent, as did businesswoman Agnes Kagure. Kananu has also thrown her support behind Igathe.

The two frontrunners have picked fairly new faces in city politics as their running mates. Sakaja has chosen former Absa Bank Chief Operating Officer Njoroge Muchiri while Igathe, also a former banker, has picked former Kibwezi MP Philip Kaloki.

Yesterday, Tifa chief executive Maggie Ireri said the high percentage of the undecided voters could be linked to the delays by the coalitions in identifying those to carry their flags in the city.

She also said unfamiliarity of some of the candidates could have contributed to the high figure. "There was confusion and unfamiliarity around the candidates. There appears to be strangers vying for the seats. Azimio might be the most popular coalition in the city but those who are vying for governor in the coalition might not be so familiar with voters," Ireri told People Daily.

She, however, indicated it was normal to have voters waiting until after nominations to make a decision on who they will vote for.

"After the nominations you will see the number of the undecided coming down," Ireri added.

### Highest number

For the Senate contest, the poll had the highest number of undecided voters, as 73 per cent of those polled said they were yet to identify who they want to replace Sakaja.

From the survey, however, ODM Secretary General Edwin Sifuna led with 19 per cent of those interviewed, saying they will vote for him, followed by Bishop Margaret Wanjiru of UDA who got six per cent while Maina Kamanda of Jubilee, who has since dropped out of the race, was third with one per cent.

Kamanda was one of the casualties in the Azimio deal that saw Igathe chosen for governor while he stepped down for Sifuna.

Wanjiru was also prevailed upon to forgo her governor's ambitions in a deal struck by Ruto that saw her vie for the post instead.

For the Woman Rep seat, incumbent Esther Passaris (ODM) topped with 27.8 per cent while Millicent Omanga (UDA) was second with 6.2 per cent.

Yesterday, Omanga contested the survey, saying they were meant to drive a particular political narrative.

"Opinion polls (are) tailored to achieve a certain narrative. Ground ndio kusema. DP Ruto has the people and that is what matters," she tweeted.

In the presidential race, Raila led with 41 per cent support of those polled in the city while Ruto second with 26 per cent although many were also still undecided (32 per cent).

### Construction of Olkaria 1 complete

The multi-billion shilling Olkaria 1 Unit six power plant is complete and will be commissioned next month. It is expected to generate an extra 83MW into the national grid. According to KenGen, the power plant was undergoing tests before official commissioning as the government moved in to increase green energy. Already, the power generating company has embarked on exploring more geothermal power in Eburru area and rehabilitating the existing power plants in Olkaria. Speaking in Naivasha yesterday, KenGen General Manager Mary Maalu (pictured) says demand for power was on the rise as more companies and consumers sought electricity. Under the company's plans, KenGen had targeted 83.3MW from Olkaria 1 Unit six by May. By 2025, the company was targeting 40MW from turbine upgrading and 50MW from wellhead leasing around the geothermal rich area of Olkaria.

## State releases funds to cushion vulnerable households

The Government has released Sh8.6 billion for the Inua Jamii programme to be paid from tomorrow.

Public Service Ministry yesterday said a further Sh27.1 million has been disbursed for Nutrition Improvement through Cash and

Health Education (NICHE), a complementary programme.

"Funds have been credited to the accounts of 1,071,856 Inua Jamii beneficiaries. Each of the beneficiaries will receive Sh8,000 being payment for November-December 2021 and January-February 2022 payment cycles," the ministry said in a statement yesterday.

The ministry, some 7,454 ben-



eficiaries will receive a top up of Sh3,000 and Sh6,000 respectively, for three payment cycles (July-August 2021, November-December 2021 and January-February 2022).

Another 3,400 HSNP beneficiaries will receive top up of Sh2000 and Sh4,000 respectively for two payment cycles (November-December 2021 and January-February 2022).

# 20 MPs on spot over constituency funds

Auditor General says millions of shillings in NG-CDF cannot be accounted for

With less than three months to the General Election, at least 20 Members of Parliament have been accused of misusing National Government Constituency Development Fund (NG-CDF).

Auditor General Nancy Gathungu in her report says the MPs failed to account for millions of shillings.

In the reports tabled by leader of Majority in the National Assembly Amos Kimunya last month, Gathungu raised queries about irregular disbursement of bursaries, unsupported cash withdrawals, stale cheques, unsupported projects and projects that were not implemented.

Gathungu also pointed out that some of the projects financed by NG-CDF were poorly implemented while others had inflated costs.

Among the constituencies that have queries are Tim Wanyonyi's Westlands, Otiende Amollo's Rarieda, Mohamed Ali's Nyali, Naisula Lesuada's Samburu West, Nduati Nguigi's Gatanga, Kwenya Thuku's Kinangop, Benjamin Gathiru Embakasi Central and Mohammed Maalim's Mandera East.

Others are Jayne Kihara's Naivasha, Beatrice Kones Bomet East, Shadrack Mose's Kitutu Masaba, Joseph Manje's Kajiado North, Moses Lesonet's Eldama Ravine, Mercy Gakuya's Kasarani and Joshua Kimilu's Kaiti.

## Bursary funds

In Westlands constituency, Gathungu has raised concerns over the disbursement of bursaries worth Sh32.8 million to secondary and tertiary institutions which she said was not supported by documentary evidence including applications forms, approval process, acknowledgement by learning institutions and the list of beneficiaries.

"In the circumstances, the accuracy and validity of Sh17,344,600 and Sh15,484,124 bursary disbursement for the year ending 30th June 2020 could not be confirmed," the report says.

The auditor also said there was irregular purchase of furniture worth Sh3.9 million for Nairobi School yet the Project Management Committee (PMC) was not consulted contrary to section 57 of NG-CDF ACT 2015.

In Naivasha, Gathungu raised queries over what she said was unsupported bursaries of Sh37.3 million out of

which Sh18.6 million was not supported by schedules.

"The accuracy and validity of bursary payments included in other grants and transfers amounting to Sh61.6 million could not be confirmed," the report reads.

In addition, Gathungu revealed there was unsupported compensation of employees amounting to Sh2.2 million, unsupported committee expenditures of Sh9.6 million, incomplete 57 projects amounting to Sh82 million as well as anomalies in bank reconciliation.

In Kinangop constituency, Gathungu pointed out anomalies in bursary disbursement to secondary schools amounting to Sh23.1 million out of which there were double payments of Sh259,200 to 30 students bearing the same registration numbers but different names while another Sh34,000 was paid to six students whose admission numbers were missing.

Gathungu also raised concern about stale cheques worth Sh1.9 million, irregular payment of Sh135,000 to non-committee members and irregular payment of committee allowances worth Sh1.3 million.

Other queries are unapproved hospitality suppliers and services expenditure amounting to Sh9 million, irregularities in projects and irregular purchase of a school bus amounting to Sh7.2 million for Heni Secondary School. The money was supposed to purchase a 52-seater school bus but a 46-seater was bought instead.

In Rarieda, Gathungu said there was irregular expenditure of bursary funds amounting to Sh41 million.

She noted that various anomalies were discovered including lack of minutes showing how the students were

identified.

She added that despite bursary payments schedules amounting to Sh5 million being raised, the cheque drawn for the expenditure amounted to Sh5.9 million resulting in

unexplained overpayment of Sh860,332.

In Nyali, Gathungu pointed out irregularities in re-allocation of bursaries totaling to Sh23.2 million.

"There was no evidence that

the re-allocation was approved by the NG-CDF. As a result, the legality of the bursaries to secondary schools balance of Sh23.15 million could not be ascertained," adds the report.

The report says there was doubtful delivery of goods to Kongowea Secondary School meant for fixing of wooden shelves for the library worth Sh624,580 and another payment of Sh800,000 for supply and delivery of office furniture and equipment to Kadzandani Kwa Bulu Post.

In Gatanga constituency, the MP has been named over Sh8.7 million bursaries for needy students in secondary, tertiary and special institutions which could not be ascertained.

In Kasarani, Gathungu questioned bursary disbursements amounting to Sh9.7 million that were not supported with acknowledgement letters from the recipients institutions.

In Kitutu Masaba, she raised queries over the purchase of school buses amounting to Sh22.4 million. The four buses were bought from dealer without ownership documents.

In Molo, the MP is on the spot over disbursement of bursary funds to a private tertiary institution for 216 students to enroll for short courses at a cost of Sh5 million.

She also raised queries about delayed implementation of nine projects worth Sh14.7 million.

**Productive jobs role in improving quality of life**

Unfortunately, Kenya's manufacturing sector is faced with a double conundrum - while the nominal value of output is growing, the sectoral contribution to the overall Gross Domestic Product is falling. Secondly, the share of formal employment in the manufacturing sector is stagnant. Growing the quantum of manufacturing jobs is important because it provides an avenue for decent wages in addition to ensuring that labour productivity is raised. Granted that the Kenyan economy has sufficient labour reserves, manufacturing sector priority and the country converges in expanding jobs in the sector. We cannot speak of job creation without increasing women's participation in traditionally male-dominated sectors, such as manufacturing. According to a Women in Manufacturing Report in Kenya, 2020, companies in the manufacturing sector are predominantly male-owned and staffed across all subsectors. The number of young women in manufacturing is even lower. This is attributed to the lack of capital finance, appropriate business development services, and the absence of specialised professional and technical human resources. Additionally, biases

and stereotypes, and gender-neutral laws and policies hinder the participation of women in the sector. On the other hand, some women-owned businesses are stuck in the informal economy and are unable to formalize for sustainability. When it comes to the growth of industry, it is apparent that women's role is invaluable. Their participation does not only increase their agency as individuals in the economic development of any country but also, encourages the proliferation of other women into starting businesses or monetizing their talents. Increasing participation of women in manufacturing calls for a deliberate effort to review specific laws, that affect the manufacturing sector through a gender lens and create guidelines for gender-responsive implementation. On the other hand, STEM awareness campaigns aimed at girls and young women shall encourage them to take up STEM subjects and join TVET or other skills-based course. Public policy dialogue that is integrative, inclusive, and responsive to the needs of women in manufacturing is paramount. KAM continues to advocate for company policies that encourage women's participation industry. We are all invested in increasing the quality of life for all citizens in the country, but we must apply measures that are sustainable and guarantee long-term benefits for our country. ### Britain probes 'fake priest' breach near queen's castle

The British army has launched an investigation after reports a man, pretending to be a priest, spent a night at a barracks with soldiers tasked with protecting Queen Elizabeth near her Windsor Castle home.

It was reported the imposter was allowed onto the barracks of the Coldstream Guards without showing any credentials or identifiable documents and later ate, drank and shared stories with soldiers.

The queen was not in during the incident which took place last Wednesday.

"The army takes this breach of security extremely seriously and it will be thoroughly investigated as a matter of priority," a Ministry of Defence spokesperson said. "This incident is now part of an ongoing investigation and would be therefore inappropriate to comment further at this time."

The Coldstream Guards are a serving infantry regiment in the British Army whose responsibilities include the ceremonial role of protecting royal palaces.

The queen returned from a short break at her Sandringham home last Wednesday but Buckingham Palace said she was not present at Windsor at the time the man was escorted from the barracks.

A palace spokesman said the incident was a matter for the defence ministry.

The man had claimed to be a priest and told officers he was a friend of a member of the battalion's chaplain. He was then invited in and had something to eat and drink and proceeded to tell lots of "tall stories".

Suspicion about his identity began to be raised when he "started talking about how he had worked as an ejector-seat test pilot and had some organs replaced".

# Get immunised, give your system a fighting chance

The world marked World Immunisation Week last week, which presents us the opportunity to remind ourselves of the lessons learnt from the Covid-19 pandemic.

The crisis could provide useful lessons for longer-term change to build greater resilience in the systems that support well-being over time.

When vaccination services are disrupted, even during emergencies, the risk of vaccine-preventable disease outbreaks increases. Without vaccines, outbreaks of the diseases may result in increased illness, worsened malnutrition and even deaths among children and further burden the health system already under pressure due to Covid.

Official data by WHO and UN International Children's Emergency Fund (Unicef) shows a majority of countries experienced drops in childhood vaccination rates in 2020 due to global service disruptions caused by the pandemic. With many resources and personnel diverted to support the Covid response, there were significant disruptions to immunisation service provision in many parts of the world.

Without the relevant vaccinations, outbreaks of vaccine-preventable diseases may result in increased illness, deteriorating malnutrition and even deaths among children. This will, in turn, place a greater burden on the health system.

According to WHO director-gen-

eral Tedros Ghebreyesus, it is more urgent than ever to invest in childhood vaccination to ensure every child is reached, as multiple disease outbreaks would be catastrophic for communities and health systems battling Covid.

Community Acquired Pneumonia (CAP) exerts a substantial burden on older adults, with incidence rates varying from about 200 to 7,000 cases for every 100,000 people in some countries. CAP is a serious disease that has a large impact on both the healthcare system and individuals and is by far more common in sub-Saharan Africa than in Europe or North America.

A rise in the aging population in Kenya is increasing the need for pneumococcal adult vaccination. The most common risk factors for acquiring CAP and invasive pneumococcal disease (IPD) included Diabetes mellitus, alcohol misuse disorders, chronic obstructive pulmonary disease (COPD), asthma, smoking, cancer, cerebrovascular disease, chronic kidney disease and HIV infection.

The comorbidities and risk factors are on the rise in the Kenyan adult

population. Having two or more comorbid conditions drastically increases the incidence of pneumococcal CAP.

The incidence of pneumococcal pneumonia among adults is often underestimated as many affected people are treated outside of a hospital setting, and it is challenging to collect samples to identify the cause of the infection.

Even within the hospital, diagnosing what is causing the infection can still be difficult.

While children need immunisation, it is clear that adults need protection too, whether it is in the form of an annual flu vaccine or where they may be at risk of vaccine-preventable diseases as a result of their age, job, lifestyle, travel or health conditions.

And, let's face it, adults with busy lives do not want to be laid low by an illness that could have been prevented as this could mean missed work, high medical bills and not being able to fulfil their day-to-day commitments.

Immunisation against infectious diseases, prevents deaths every year in all age groups from diseases

like diphtheria, tetanus, pertussis (whooping cough), influenza and measles. It is one of the most successful and cost-effective public health interventions.

Vaccines work with your body's natural defenses to help you safely develop immunity to disease. This lowers your chances of getting certain diseases and suffering from their complications.

You have a busy life and too much responsibility as an adult to risk getting sick. Vaccines can help you stay healthy so you don't miss work. If you can avoid getting sick, you will have more time for your family, friends and hobbies.

Adults need to keep their vaccinations up to date because immunity from childhood vaccines can wear off over time. You are also at risk for different diseases as an adult. Remember, vaccines are used to boost your immune system and prevent serious, life-threatening diseases.

Even though getting the necessary vaccines during the pandemic may seem challenging at times, getting recommended vaccines can give you some peace of mind.

His comeback bid has been stopped in its tracks by a zoning move by Azimio La Umoja principals. He cannot run in his favoured Embakasi South constituency. "I am frustrated. I am disturbed. I have spent so much money and time and it is frustrating that zoning has taken place," says Sumra at a lawyer's office in Agip House, Nairobi.

His prayers for a bid to capture his old seat hang on a decision by Wiper Party to reject zoning in Nairobi. The party, led by Nairobi



chairman Roy Kivusyu, has opposed a decision by the Azimio Coalition to zone Nairobi.

Speaking at Sagret Hotel, Kivusyu said the move undermines the spirit of democracy and Wiper stands to lose. He was flanked by Nairobi MP aspirants Ben Milai from Mathare, Fred Akech (Makadara), Tabitha Muteru (Kasarani) and Joash Ongwa (Embakasi East). Others included Nairobi MCAs aspirants.

He said the Kamba commu-

nity is the second largest voting bloc in Nairobi and cannot be relegated to a few seats. In the zoning, Wiper was allocated Embakasi South seat, with Julius Mawathe as its candidate.

In the Azimio line-up, ODM has bagged Mathare under MP Anthony Oluoch, Embakasi East (Paul Ongili), Ruaraka (TJ Kajwang), Makadara (George Aladwa) and Westlands (Tim Wanyonyi). From Jubilee, Roysambu will be contested by Ndirangu Waihenya, Kasarani (Mercy Gakuya), Kamukunji (Abdi Yusuf Hassan), Dagoretti South (Dennis Waweru), Embakasi North (Harrison Wangoro), Embakasi West (Mark Mwenje), Embakasi Central John Ndirangu) and Starehe (Amos Mwago).

# Nyamira governor seat attracts eight contestants

Clannism expected to play a role in the polls, pitting the Abagetutu against the Abagirango

The race for Nyamira County governorship has gained momentum, with clannism set to play a major role in determining the winner.

Governor Amos Nyaribo will be seeking re-election on the Progressive Alliance Party (UPA) after he ditched Amani National Congress (ANC), which sponsored his candidature in the last General Election.

Other aspirants are Walter Osebe Nyambati (UDA), Ben Momanyi (Wiper), Timothy Bosire (ODM), Joseph Kiangoi (ANC), Reuben Marwanga (Kanu), Mwanicha Okioma (Jubilee) and James Kemoni (PNU).

Five of the eight aspirants have already named their running mates.

### Dropped ambition

Nyaribo has picked former West Mugirango MP James Gesami as his deputy, while Nyambati has named Ereneo Nyakiba after the latter dropped his governorship ambition.

Momanyi, who is the Borabu MP, has settled on Tom Otuto from West Mugirango.

For the past 10 years, Otuto has contested the seat unsuccessfully.

Kiangoi, who is a former North Mugirango MP and assistant minister for Local Government, has picked banker and entrepreneur Julius Mokogi as his running mate.

"My deputy and I have wide experience in both the national government and the corporate world. Given a chance, Nyamira will shine," Kiangoi told his supporters.

Okioma, who contested the seat in the last polls but lost to John Nyagarama (deceased), has settled on Moi University lecturer Charles Nyandusi as his deputy. Those yet to

name their running mates include Bosire, Marwanga and Kemoni.

Clannism is expected to play a central role in the contest. The county has two main clans: Abagetutu and Abagirango. Twice, the Abagirango have outdone the Abagetutu, with the election of Nyagarama.

Nyaribo, Momanyi, Kiangoi, Kemoni and Marwanga are from Bogirango clan while Nyambati, Bosire and Okioma are from Bogetutu. Interviews revealed that Nyaribo, Nyambati, Momanyi, Bosire and Okioma are the front-runners.

Disappointment over chaotic primaries — which made some aspirants become independent candidates, could also tilt the contest.

Nyambati (UDA) and Bosire (ODM) have urged residents to reject aspirants trumpeting the clan factor. Addressing boda boda riders at Rangenyo in West Mugirango constituency on Monday, Nyambati accused Nyaribo of fanning clannism.

"Elect leaders based on competence and performance; not on clan lines," Nyambati told the riders.

Bosire echoed the sentiments, saying clan politics had adversely affected development in the county.

"We are asking our people to discard clannism. Reject leaders dividing the county," Bosire said.

Nyaribo's administration is also accused of investing resources from

Nyamira in nearby Kisii county.

"We need a governor who can change the culture where workers take money from Nyamira to invest in other counties. Some county workers are also operating from Kisii, affecting service delivery", resident John Ogwora said.

### Big task ahead

Governor Nyaribo has a big task of convincing residents to re-elect him following accusations of mismanagement of county resources and poor health services. A number of county employees have also ganged up against him after he attempted to demote them five months ago.

Members of the county assembly also accuse him of failure to release bursary funds in time. "We are asking the governor to release the money in a week, failing which we will tell beneficiaries to camp outside his office," said Duke Masira, the county's majority leader.

But Nyaribo blamed the national Treasury for the delay. "We received the money two weeks ago and are currently disbursing the funds to various institutions," Nyaribo said.

He added that MCAs take too long to submit the required information on the beneficiaries. "The MCAs are not honest. They are merely inciting the public against my administration," he said.

## Man, 71, trounces 14 youthful aspirants in UDA Nandi ward poll

A 71-year-old won the first round of the battle for Member of County Assembly (MCA) seat after he trounced 14 aspirants in Nandi county in the just-concluded United Democratic Alliance (UDA) polls.

Raymond Chelule could be the oldest MCA in Deputy President William Ruto's North Rift backyard if he wins the August 9 elections.

### Poverty alleviation

In an interview with *People Daily*, Chelule said his main agenda for Songo/Sovo Ward would be to improve the infrastructure. "I would also focus on poverty alleviation, which is a key agenda of UDA's bottom-up economic model. My priority would be the youth," Chelule said.

"Creating employment is a way of empowering the people. Even if one is not formally employed, one can do other things to benefit oneself," he added.

His political journey started with an appeal to the grassroots to back his vision.

"I did not give the electorate anything. They just saw

the potential in me. I will not let them down," he said.

In 1997, he unsuccessfully contested the Tinderet parliamentary seat against former powerful cabinet minister Henry Kosgey, on the Raila Odinga-led National Democratic Party (NDP). Kosgey was on a Kanu ticket.

"I made a big political statement then since Kanu was in power and it was difficult to be elected on an opposition ticket," he said.

Chelule cleared a Bachelor of Science degree course at Makerere University (Uganda) in 1975 and worked at Chemelil Sugar Company for eight years and Miwani Sugar for another eight years.

He then moved to Kenya Meat Commission (KMC) for six years before plunging into politics after being approached by NDP.

"Although Kosgey carried the day, my supporters had hope in me," he recalls.

He came second in the election after garnering 10,000 votes against Kosgey's 24,000 votes.

"I had a sizeable number of voters despite the party I was in at the time," says Chelule, who also wants to improve the early childhood development (ECD) sector.

# Government fights yellow fever attack in 12 NEP counties

Eleven people have so far died since the disease was first reported

The government is fighting the outbreak of yellow fever in at least 12 counties in northern Kenya.

Ministry of Health says 11 people have so far died while at least 90 suspected cases have been reported over the last two months.

Dr Emmanuel Okunga, the head of the division of disease surveillance and response, says the high-risk counties are Isiolo, Marsabit, Samburu, Elgeyo Marakwet, Garissa, Tana River, Meru, West Pokot and Mandera, Turkana, Wajir and Baringo.

Okunga said the country, which has not experienced an outbreak of yellow fever since the 1990s, detected the first case around January in Merti, Isiolo, which has been hardest hit, and since then, more than 90 cases have been identified presenting with symptoms of yellow eyes, yellow urine, severe bleeding through the nose, mouth and any other opening, and failure of body organs such as kidneys, lungs and liver.

He says although most infected individuals may not exhibit any symptom, those lucky enough to manifest them will experience headache, fever, jaundice, muscles and joint pains.

Yellow fever is described by medics as an acute viral hemorrhagic disease transmitted by

infected mosquitoes. Mosquitoes mostly draw the infection from primates.

"The hardest hit sub county is Merti in Isiolo where herders congregate and interact with primates, particularly baboons along the Ewaso Ngiro basin. The disease is usually transmitted by mosquitoes from baboons to human beings," says Dr Okunga.

## Human transmission

The disease is also transmitted from humans to humans via the mosquito, which sucks up the virus and then hands it on when it bites someone for a blood meal.

Okunga assures that the risk of further spread was low as the outbreak was in a sparsely populated region.

"Because of the demographics of Isiolo, in terms of the number of people and how people are widely spread apart, it makes it a little easy to control," he states.

Okunga says that they had to move fast because any delay would have likely seen the disease spreading to other

counties and thereby leading to Kenyans travelling to other countries being subjected to production of yellow vaccination certificates as a requirement for entry.

To contain the situation, Dr Okunga told the *People Daily*, the Ministry has dispatched a team to spray, undertake epidemiological investigations and to identify the affected individuals wherever they are and when they get infected.

The government has also requested for yellow fever vaccines from the World Health Organisation (WHO) in order to heighten vaccination in the 12 affected counties.

WHO advises that yellow fever is prevented by an extremely effective vaccine, which is safe and affordable. A single dose of yellow fever is sufficient to grant sustained immunity and life-long protection against the disease.

A booster dose of the vaccine, WHO says, is rarely ever needed since the vaccine provides effective immunity within 10 days for 80-100 percent of people vaccinated and within 30 days for more than 99 percent of people vaccinated.

Other than spraying and epidemiological investigations, the Ministry is also engaging local communities on how to differentiate yellow fever from other related diseases in order to combat and prevent it.

"A team from WHO is already in the country to assess the situation and offer their expertise. We are also working with county governments and several government agencies to contain the situation," said Okunga who also assured that the Ministry has effectively managed the outbreak.

## Energy experts differ over effects of Russia gas supply cut

Russia has threatened to cut off gas supply to “unfriendly” countries that fail to pay in Russian currency (rubles) in the latest retaliatory tactic to survive financial sanction by the European Union (EU), setting the stage that further constrains the already expensive liquid petroleum gas (LPG) sector.

The standoff brings two challenges; how to pay Russia gas without compromising EU sanctions and how to source alternative supplies to end dependence on Russia. Russia is the second leading producer of natural gas globally after the

United States, supplying about 40 percent of gas needed by EU countries.

Kenya, however, might not be affected directly as it imports cooking gas from gulf countries through the Tanzania and Mombasa facilities with local experts giving mixed reactions owed to the country’s unregulated LPG sector.

Cutting off access to the vital Russia gas is expected to exacerbate gas shortage, piling pressure on gas prices as affected big economies scramble for the limited supply, argues John Kirimi, financial analyst at Sterling Investment.

“If Russia withdraws its gas from the market, then the effect will be

a global shortage and the current price hike is going to worsen,” says Kirimi.

Powell Maimba, an expert in the energy sector is, however, upbeat that the gas supply cut by Russia will not affect the Kenyan gas landed cost unless there is disruption of global gas production.

### Supply system

“The Ukraine factor is already included in the current pricing. Even before the war there was a gas shortage that shot up the prices. So, the main cause of hiked prices is the global supply system and infrastructure, the demand and supply kind of a situation,” says Maimba.

Unlike Diesel, fuel, and Kerosene, LPG prices are not controlled by the Energy and Petroleum Regulatory Authority (EPRA), giving room for LPG monopoly that has left households heaving under hiked cooking gas prices. Linus Gitonga, an ex-commissioner at Energy and Regulatory Commission (now EPRA) concurs with Maimba, arguing that price volatility is not caused by a single driving force.

“It is very difficult to pinpoint if one factor contributes to price changes. Despite the war, we are currently expecting the prices of cooking gas to start going down at the end of the month due to market forces,” says Gitonga.

## Kenya’s Quickmart among fastest growing firms in Africa—survey

Two fastest-growing companies in Africa are in Kenya, a new ranking released by the *Financial Times* on Tuesday shows.

Fintech and a retail technology startup Flo-cash and Wasoko formerly Sokowatch respectively are the fastest-growing companies on the African continent.

Lori Systems also based in Kenya is number seven on the list with Nigeria having five companies in the top ten while South Africa leads with the highest number of companies on the list of 75 companies.

“Kenya is the third most represented country in the ranking, with nine companies, behind South Africa (24) and Nigeria (20), and ahead of Egypt (six),” said the *Financial Times*.

Wasoko, formerly Sokowatch, which heads the ranking, is one of several on the continent seeking to cut the cost of doing business in the massive informal sector, by helping to deliver goods to traders more. “The Kenyan company achieved the highest

compound annual growth in revenues between 2017 and 2020 and, in March, raised \$125mn in a Series B round,” said the *Financial Times* in a report.

Kenya’s Quickmart also features at position 11 due to its rapid expansion in recent years even as competing stores have shut down.

#### More entries

Other first growing companies in Kenya include Africastalking, Copia, M-Kopa, Asa International Company and East Africa Business Company.

South Africa dominates the list numerically, with more entries than any other country – but the first SA company features only at number 10. And, were it not for SA’s precious metals, Nigeria would have claimed that title too.

The FT created the inaugural list with research company Statista, and it ranks companies on the continent based on their compound annual growth rate (CAGR) in revenue between 2017 and 2020.

## Kenya, Netherlands partner to build cold chain infrastructure

**EXPORT:** Netherlands and Kenya are working to establish refrigerated shipping liners and a cold chain infrastructure to enable the latter export horticulture via the sea to cut costs and carbon emissions. Netherlands is seeking to replicate its success with Ethiopia and Djibouti exports model in Kenya to help boost trade between the two countries.

"During a meeting with Transport Cabinet Secretary, James Macharia (pictured), we signed a Letter of Intent on the shared ambition to improve a 'Cool Logistics Corridor' for perishables," Netherlands Ambassador to Kenya, Maarten Brouwer said.

This will enable short-life products, such as flowers and vegetables, to be transported as sea freight instead of air freight, thus reducing up to 80 per cent of carbon emissions.

Pilots have shown such a shift is feasible with good quality outcomes and reduced transport costs allowing Kenya to maintain its strong position in the world market for perishables.

This also means that higher volumes of exports can be ferried to Europe at a lower cost than using air transport.

Brouwer said he will continue to promote innovative entrepreneurship, exchange of knowledge and finding green solutions helping to. That is where trade and development meet: Finding the synergy between the two in the Kenyan context. He added that next to economic relations, Kenya

and the Netherlands continue to jointly work towards the achievement of the Sustainable Development Goals.

Yearly, the Netherlands contributes over Sh11 billion in development assistance to Kenya, according to the Netherlands Embassy. The embassy also says it works closely with the private sector and with the Kenyan government, more and more also at the county level.

### Horticulture market

Netherlands is a key market for Kenya's horticulture exports, especially flowers, fruits and vegetables. The horticulture market has been growing with more Kenyans joining avocado production and macadamia and other vegetables.

The industry value chain is a key source of employment for many Kenyans from the farms to processing and export.

Kenyans exported goods worth Sh69 billion last year up from Sh61 billion in 2020 while Netherlands exported were at Sh71 billion last year up from Sh56 billion in 2020.

This is one of the few countries outside Europe where Kenya has a near one-to-one trade balance.

In 2020, the refrigerated shipping industry and cold chain reached a new milestone with the successful completion of the first shipment of Ethiopian avocados to Europe and establishment of a cool logistics corridor in East Africa.

# Why banks are concerned about cybercrime increase

New survey shows 92pc of lenders say internet fraud is one of the top three innovation-related threats

Commercial banks have identified cybercrime as a major threat to innovation and launch of new products across the financial sector. A Central Bank of Kenya (CBK) survey found 92 per cent of lenders interviewed said cyber security is among the top three risks they face in their bid to come up with new products.

"Cyber risk turned out to be the key risk for institutions in their innovation endeavours, similar to the findings of the survey for 2020," it said. Ninety-two per cent of banks and 86 per cent of microfinance banks (MFBs) identified it as one of the top three innovation-related risks," the survey added.

Cyber risks in banks target data privacy and threaten data security for the bank customers and the safety of their funds.

Germany's financial regulator BaFin warned Tuesday of the "very big" risk of cyberattacks targeting the financial sector, a threat it said had become "more likely" since Russia's war on Ukraine.

"The risk that companies in the financial sector will fall victim to cyberattacks or that internal IT security incidents will occur is very big and very present," BaFin president Mark Branson told a press conference. In extreme cases, "such incidents could damage the stability of the financial system," he said. "Are we prepared for a really serious security incident? If we are honest, we don't know," Branson added.

### Hacking attempts

Ukraine and its Western allies have been on heightened alert for potential Russian hacking attempts since Moscow invaded its neighbour on February 24.

The "Five Eyes" intelligence sharing network -- consisting of the United States, Britain, Canada, Australia and New Zealand -- warned in April that "evolving intelligence" indicated Russia was planning massive cyberattacks against rivals supporting Ukraine.

The war in Ukraine "has made cyberattacks on the German financial sector more likely," Branson told reporters in

Frankfurt. The BaFin watchdog is monitoring the situation closely, he said, in cooperation with Germany's National Cyber Defence Centre. BaFin was also keeping financial firms updated on potential attack patterns, he said.

Last month's "Five Eyes" alert said Russian state-sponsored cyber actors have the ability to compromise IT networks, to steal large amounts of data from them while remaining hidden, to deploy destructive malware and to lock down networks with "distributed denial of service" attacks. Locally, Kenyan banks continue to lose billions of shillings to cybercrime every year, meaning that new digital projects are a potential avenue for exploitation by hackers.

KCB Group reported that it managed to stop a Sh2 billion attempted fraud on its banking system last year, underscoring the increase in online attacks during the Covid-19 pandemic. The bank made

public the attempted fraud without giving details on whether the attack was from foreign hackers or local techies. Kenya loses an estimated \$295 million (Sh34.17 billion) to cybercriminals annually, but there is a surge every year, experts say with a recent survey by Ponemon Institute showing 56 per cent of organisations have had a breach that was caused by one of their suppliers.

### Sensitive information

The survey also indicated that the average number of third parties with access to sensitive information at each organisation has increased from 378 to 471 which makes it easier to even target those in the supply chain to attack lenders.

Cyber attacks in Kenya recorded a significant increase in the banking and financial sector in the second quarter of 2021 compared to the first quarter of 2021, at 60 per cent.

However, banks have established innovation teams and framework that guides the decision-making process of innovating a product and a committee that reviews innovative product proposals before seeking board approval.

Some lenders like Equity Bank have even started a hacking competition dubbed Equity Hackathon which combines data, technology, creativity, and talent to shape solutions. This year the lender targeted students from The University of Nairobi and Meru University of Science and Technology.

## Kisumu County staff asked to surrender Sh99m imprest

Hundreds of employees working in Kisumu County have been ordered to surrender imprests amounting to Sh99,185,962. The imprests date back to the year 2014. The County staff then working under former Governor Jack Rungu processed the imprest.

But they didn't surrender the imprests raising audit queries whether they spent the money for the desired purpose or just squandered it.

In law, failure to submit imprest is contrary to Public Financial Manage-

ment (PFM), Regulations, 2015, and is therefore penalisable.

Kisumu County Finance Executive George Okong'o said the exercise was ordered by the National Treasury.

This is after the Auditor General Nancy Gathungu's Report found that many employees had not surrendered their imprests. As a result, the county found itself in bad books with the Auditor General finding it liable for explanation, on various financial audits.

Okong'o noted that there was damning evidence and risk of loss of public funds if this amount was not recovered in good time.

## LVBC head office project 85pc complete

Construction of the first phase Sh142 million of Lake Victoria Basin Commission (LVBC) headquarters in Kisumu is 85 per cent complete. Yesterday, LVBC Principal Administrative Officer Millicent Opiyo disclosed that phase two is to start in July.

"We are now looking forward to starting the second phase at the end of this financial year starting in July," she said. The second phase is projected to cost about \$2 million (Sh230.52



million) of the estimated total cost of \$3.5 million (Sh403.41 million).

"This includes administrative and overhead costs. The procurement process will end in July, bids evaluated, for work to start," she said. Opiyo spoke to the press during the opening

of the 21st Sectoral Council of ministers for Lake Victoria Basin Commission (SECOM). SECOM provides overall policy guidance and oversight of the commission. She said they have already received the Commission Secretariat's approval for funding for the second phase of the project.

The East African Community's (EAC) most influential institution in Kenya is being built on a 2.8-hectare piece of land fronting Lake Victoria on Nkrumah Road. LVBC is the coordinating secretariat of the EAC headquartered in Kisumu.

# Kenya's Eurobond rates surge as Russia-Ukraine feud rises

Reports indicate that Kenya's Eurobond yields have been rising sharply since February following the attack of Ukraine

Payments of interest from Kenya's Eurobond loans soared by the highest margin ever last week since the onset of the Russia-Ukraine war threatening to choke the country's access to the foreign debt market.

"In the international market, yields on Kenya's Eurobonds rose by an average of 68.5 basis points. The yield on the 10-year Eurobond for Angola also rose, while that for Ghana declined," the Central Bank of Kenya (CBK) said in its latest weekly bulletin.

Eurobonds are fixed-income debt instruments that are denominated in a different currency than the local one of the country where the bond's been issued. The primary reason for issuing Eurobonds is a need for foreign currency capital.

Reports indicate that Kenya's Eurobond yields have been rising sharply since February when Russia invaded Ukraine to overtake yields on Angola's Eurobond debt and is now almost at par with Ghana's.

## New funding

This could chase away investors from the market to the detriment of Kenya's economy.

Further, with Kenya's economy relying heavily on China the global supply chain challenges may affect the Asian giant's fortunes which may also have a direct impact on Kenya's debt situation at a time Treasury attempts to seek new funding to repay maturing loans.

The Covid-19 pandemic and fact that Kenya is a net oil importer, which exposes its economy to adverse impacts of fluctua-

tions in global prices

The war in Ukraine which escalated last week saw Russia halt gas supply to Poland and Bulgaria. Further, US equities fell amid a sharp rise in equity volatility due to poor earnings as Russia pounded Ukraine.

This has sent global commodity markets soaring with food and energy prices skyrocketing causing further spiking inflation both abroad and at home.

Last week, Kenya hinted it may suspend a planned \$1 billion (Sh115.26 billion) Eurobond debt issue, on account of the rising yields and uncertainty on the international market. Fears abound that rising yields globally will make the borrowing expensive.

This has seen the exchange rate deteriorate making it hard for the Kenyan government to service its debt obligation as foreign exchange becomes even harder to get with banks being accused of hoarding forex.

Apart from avoidance of currency or forex risk, Eurobonds were supposed to

expose Kenya to a huge range of bond maturity periods and also broaden the potential investor base.

Global oil prices dipped during the week ending April 28 after the US administration reported a modest crude oil inventory build-up while Murban oil prices decreased to \$104.68 per barrel on April 21 compared to \$108 per barrel on April 14.

As of April 28, the usable foreign exchange reserves remained adequate at \$8.4 billion, or 5.01 months of import cover, which is fine by the regional standards.

## Loans cushioned Kenyan economy

"This meets the CBK's statutory requirement to endeavour to maintain at least 4 months of import cover, and the EAC region's convergence criteria of 4.5 months of import cover," the CBK said.

Last week, the International Monetary Fund said it had reached an agreement to provide Sh28 billion to the central bank to help Kenya deal with external shocks and inflationary pressures while USA noted the loans cushioned Kenyan economy.

## Dubai virtual assets regulator enters metaverse

Dubai's virtual assets regulator said Tuesday that it was entering the metaverse and establishing a new headquarters on platform The Sandbox, state news agency WAM reported.

The announcement makes Dubai's Virtual Assets Regulatory Authority (VARA) the "world's first regulator to make its debut in the metaverse", according to WAM.

The move reflects Dubai's "confidence in virtual assets being integral to the future digital economy, and its readiness to establish the emirate as the world's virtual assets capital", the news agency added.

The metaverse, touted by Meta and other companies as the future of the internet, consists of a set of parallel "universes" accessed primarily through augmented and virtual reality platforms.

Dubai Crown Prince Sheikh Hamdan bin Mohammed was quoted by WAM as saying the emirate was "ushering in a new era" in which the Dubai government "utilises modern innovations to extend its services and regulatory power to audiences in an open technological expanse". The authority was established in March under the emirate's first law to regulate virtual assets.

Meta, which changed its name from Facebook last year, has invested heavily in the metaverse, a 3D virtual world that will see people interact through avatars. In November, Barbados announced that it would establish the world's first diplomatic embassy in the metaverse.

In the long-term, these measures will improve profit, reduce business risk and deliver the desired effect which is to slow down the rate of global warming.

By integrating green financing structures, banks can indirectly influence an accelerated adoption of green solutions in carbon-intensive industries such as manufacturing and transport, which account for 35 per cent of global greenhouse gas emissions.

Through green financing mechanisms, financiers gradually reduce their investment in low-end industries that are guilty of environmental pollution and increase their investment in green energy industries.

Financing policies can help banks

divert the flow of funds to green industries, thus spur rapid improvement of the national green development level, and help save the world.

Private and public sector players are appreciating the gravity of the matter and taking action. The Kenya Bankers Association (KBA) has initiated Sustainable Finance Initiative (SFI) programmes to train bank employees on how to scale up green financing models and partnerships.

Absa Bank recently signed a Sh1.25 billion Credit Guarantee Scheme with the Africa Guarantee Fund (AGF) to women entrepreneurs as well as mid-sized businesses qualifying as green transactions.

The Capital Markets Authority (CMA) has appreciated the Absa Af-

rican Financial Markets Index (AFMI 2021) for championing sustainable finance products such as green bonds, equities and mutual funds in the market.

Last year, the Central Bank of Kenya (CBK) released Climate-Related Risk Management guidelines to facilitate the integration of climate-related risks in governance, strategy, risk management and disclosure frameworks by local banks. The guidelines also spell out transition risks and how to mitigate them. These guidelines provide an opportunity for banks to lead a national drive towards accelerated change and transformation of the country to a low carbon economy.

The government can support this agenda further by creating pro-sustainability policies such as tax reductions which encourage banks to invest more in supporting eco-friendly businesses.

## US reacts to ouster of abortion law

Leak indicates Supreme Court is poised to overturn landmark safe abortion for women across the US

US Supreme Court is set to overturn a landmark ruling allowing abortion for women across the country, according to a leaked draft opinion published by *Politico* magazine.

The news outlet said it had obtained an initial draft majority opinion written by Justice Samuel Alito that showed the court had voted to strike down the 1973 *Roe v Wade* ruling. The leaked draft does not represent an official decision on the matter, and there is still the possibility that votes could change as deliberations continue. Here is how various members of the Democratic and Republican parties, rights groups and legal centres have so reacted to the news:

### Democrats

In a joint statement, Speaker of the House Nancy Pelosi and Senate Majority Leader Chuck Schumer said the court seemed "poised to inflict the greatest restriction of rights in the past 50 years –

not just on women but on all Americans". Rounding on the "Republican-appointed" members of the court, the statement said a vote to overturn *Roe v Wade* "would go down as an abomination, one of the worst and most damaging decisions in modern history".

New York Governor Kathy Hochul, also a Democrat, said the draft opinion was a "disgraceful attack" on women's right to choose and said abortion would "always be" safe and accessible in New York. Hillary Clinton, former secretary of state, former first lady, and a Democrat who ran for the presidency, called it "outrageous".

### Republicans

Meanwhile, former presidential candidate Bernie Sanders, an Independent who caucuses with Democrats, said *Roe v Wade* must be codified as the law of the land. Many Republicans hailed the ruling. "The left continues its assault on the Supreme Court with an unprecedented breach of confidentiality, clearly meant to intimidate," said Republican Senator Josh Hawley. "I will say, if this is the Court's opinion, it's a heck of an opinion. Voluminously researched, tightly argued, and morally powerful."

Several rights groups condemned the draft ruling.

The president of abortion rights advocacy group Planned Parenthood, Alexis McGill Johnson, said: "This leaked opinion is horrifying and unprecedented, and it confirms our worst fears... While we have seen the writing on the wall for decades, it is no less devastating, and comes just as anti-abortion rights groups unveil their ultimate plan to ban abortion nationwide... [We] will continue to fight like hell to protect the right to access safe, legal abortion."

The National Women's Law Centre said: "The language in the draft opinion leaked from the Supreme Court is outrageous, irresponsible and shocking. Any Justice who signs onto this opinion is fuelling the harm and violence that will happen to people who become pregnant in this country."

#### Curfew imposed in state capital following Hindu-Muslim clashes

Government authorities have imposed a curfew and cut off internet connections in an area of Jodhpur, the capital of northern India's Rajasthan state, following fresh altercations between the Hindu and Muslim communities there. Al Jazeera's Elizabeth Puranam said there was a "very heavy police presence" in the Jalori Gate area, following more fighting between the two groups. The clashes began on Monday during religious festivals for both communities, each of whom wanted to raise

religious flags in the same area. Muslims were marking the end of Ramadan month of fasting, and Hindus were celebrating a festival called Parshuram Jayanti. Things had calmed down overnight, and Eid prayers took place on Tuesday peacefully. However, clashes between Hindus and Muslims later erupted again in at least five different areas in Jalori Gate. "Local media is saying at least 10 people have been injured and one person has been taken to hospital," Puranam said.

#### AU forces foil military base attack in central Somalia

African Union Transition Mission in Somalia (ATMIS) repulsed a deadly pre-dawn attack by the al-Shabab militant group on its military camp in the central Somalia town of El Baraf, local security officials confirmed Tuesday. The local security officials told Radio Mogadishu that two loud explosions hit the ATMIS base manned by the Burundian troops followed by an exchange of gunfire between the troops and the

militants." ATMIS troops of Burundi contingent have repulsed a complex attack by the terror group al-Shabab on an army base in El-Baraf town of Somalia's Hirshabelle State in the early hours of Tuesday," the state-owned radio reported. There was no comment from the government or ATMIS officials on the latest assault by the extremist group. Al-Shabab claimed responsibility for the attack.

## Mali junta breaks French defence accords

■ Bamako, Tuesday

Mali's ruling military has announced it is breaking its defence accords with former colonial ruler France, condemning "flagrant violations" of its national sovereignty by the French troops stationed there.

The announcement was the latest sign of deteriorating relations between Mali and France.

Authorities in Bamako said they had informed Paris of the decision on Monday

afternoon. France so far has not issued an official reaction to the announcement.

"For some time now, the government of the Republic of Mali notes with regret a profound deterioration in military cooperation with France," spokesman Colonel Abdoulaye Maiga said in a televised statement.

Maiga cited multiple instances of French forces having violated the country's airspace. He referred to the June 2021 move by France to end joint operations with Malian



forces and mentioned another decision taken in February to pull French troops out of the West African state.

The agreements Mali has ended were those that set the framework for France's intervention in Mali in 2014.

They were signed a year after France deployed a large force to help Mali's army stop an offensive by armed groups there.

Tensions between France and the military government in Mali, which seized power in August 2020, had been rising for some time.

Since then, France's relationship with Mali has worsened as the government resisted international pressure to set a timetable for a swift return to democratic governance. - AFP

## Misconceptions on 5G technologies debunked

**Y**ou recently launched your first 5G mobile phone in the Kenyan market. Do you think the country is ready for the 5G technology?

Yes, Kenya is ready for the 5G technologies. We have seen operations to test 5G capability lately. For instance, Safaricom recently confirmed that it is planning to launch a commercial 5G network in 2022 and 2023. It also has a greater number of connected devices and the possibility of implementing virtual networks (network slicing), providing more adjusted connectivity to concrete needs. This provides faster internet speeds that help in faster downloading and communication. 5G technology will revolutionise how different industries operate. These network improvements will have far-reaching impacts on how people live, work, and play all over the world.

**Which industries will benefit most from the 5G network?**

Although it is still in the early stages, this fifth-generation technology, will effectively fuel innovation and increase performance across a number of industries simultaneously when utilised well. This will range from healthcare, hospitality, financial services, manufacturing, transportation, entertainment, agriculture and

# Family Fusion ▶ All about kin and kith

## Rediscovering self after losing identity in marriage



When you get married, it is easy to let yourself go and get swallowed in your partner's career and ambitions. **Chari Kingsbury** shares how she got herself out of this scenario

Four years after US couple Chari and Chip Kingsbury got married they were sent to Kenya as missionaries. The two first settled in Nyeri, where they ministered and started churches as well as taught in Bible schools between 1980 and 1993. But when Chari got to her 40s, a sense of dissatisfaction overwhelmed her.

"When I got married, I was shy and quiet, but my husband had and still has a dominant and outgoing personality. So, it was kind of easy giving up my things and being overshadowed by his personality. At some point, this was my own crisis and I was really angry at him at first. I was feeling like what I was doing in a foreign country, I could still do it in the US, so why was I still here?" narrates the mother of three.

### Struggle for life purpose

Many married women are sometimes forced to give up their careers, friends, dreams or passion for their families or to assist their spouses do their businesses. While some end up loving this compromise, there are others who feel like they have to find their purpose and add meaning to their lives.

Chari shares how she was afraid to tell Chip that she wasn't happy because he

seemed to enjoy his missionary work and the new country. However, one time when they went for a break in the US, she shared her predicament with a pastor friend who encouraged her to talk with her husband.

"We went out for dinner and I told him that I had something important to talk about. He just listened quietly and then we decided to pray about it till God gives me a vision on what He wanted me to do. We both started praying separately and one day, I shared with him what I wanted to do. I thought of starting mentorship programme for university students. That is how Ukarimu Ministries started through my husband's help. We would help students with a variety of problems from stress over exams, to working through past issues in their families, to how to develop healthy, godly relationships," she shares.

During this period of exploration, Chari discovered that she allowed things to happen in her life without setting boundaries. She took time to rediscover herself. The period was a bit painful for her husband as he wasn't used to his wife saying 'no' or expressing opinions contrary to what he wanted to do. "It was a tough period, but necessary and I thank my husband for being supportive through the process of exploration and discovery. I think in the end, since I was happy, he was happier too because he had a contented wife instead of an angry one," says Chari.

Relationship expert Dayan Masinde ob-

serves that both men and women can easily lose themselves in marriage. "Largely because, many think that to love is to die to self-growth and individual ambitions and yet marriage ought to provide an environment for you to be best version of you. The one who loves you, loved you for you and in marriage, they want you to continue being you. We live in a society where many idolise marriage and have made marriage their identity and meaning; marriage is a season of two whole individuals walking together without stopping to be whole. Don't shelve your dreams and goals, complement them; you were created for more than marriage," he explains.

Dayan says that the dangers of losing yourself in marriage is that it puts one in undue pressure, which leads to frustration.

### Much more than a spouse

"Over time, when you don't make progress as a person in marriage, you will begin to develop low self-esteem and become insecure with your spouse, jealous towards your peers, self-sabotaging in your actions, harsh towards your children, bitter towards your friends, reckless in your decision making and even abusive or resentful towards your spouse. You will see your spouse as the reason your life stagnated, your voice shrank and you lost your way, yet personal growth is your personal responsibility; some things you

cannot delegate," he notes.

To avoid this, Dayan advises couples to find themselves and discover what contribution they want to make in the family and life.

"Find out what legacy you want to leave behind, what your values are, who are you besides the role of spouse and parent, how can you grow emotionally, mentally, spiritually, socially and professionally? Share this with your spouse and find out your spouse's individual potential too. Love you as you love your spouse, you cannot pour water from an empty jug. Make each other secure so that you can allow each other to grow without feeling suspicious or threatened; many times, spouses inhibit each other's growth and voice due to insecurities. Don't always wait for your spouse's approval or validation; grow in every area, but grow without friction towards your spouse — grow together," he continues.

### Fulfillment in vision

Also, having a vision as a couple that can accommodate both your individual visions will also assist in fulfillment.

"Remember, marriage will not bring your fulfillment, if you are not fulfilled as an individual. Love is mutual, it is not just about looking after the interests of your spouse, but your interests too. Build a marriage that brings out the best in you," he advises.

Chari shares how in 2008, the two decided to expand Ukarimu Ministries to not only deal with university students, but also family at large.

"I was studying for my Master's in Counselling Psychology and was preparing for my practical examination. A pastor told me to design some kind of a group counselling programme for troubled marriages. I managed to come up with a first group of three couples. I was worried that no one would share their marriage issues in a group, but interesting enough, people were open enough to share their struggles. From that, we decided to expand our Ukarimu Mission to also cater for family needs. We began to offer marital and premarital and individual counseling, marriage enrichment seminars, parenting seminars among others," she says.

Chari does not regret the direction her life and her family has taken, and the fact that she is impacting others leaves her fulfilled.

# We planned for three children, but got six

Despite losing their third child, who was meant to be their last born, **Mullen Awuor** and her husband **Pastor James Ochieng Magak** went ahead to get four more, some conceived even when Mullen was on family planning. They share their highs and lows in their marriage life

**W**hen Mullen Awuor Oigo Magak and her husband Pastor James Ochieng Magak lost their third born child when he was only three months old, they were shattered and devastated.

"When we got married, we planned to have three children, but when our third born child passed away, we asked God a lot of questions. God revealed to us that due to the loss we suffered he would reward us four times. And from that point I just embraced and loved the idea of having a big family," says Mullen.

And indeed, this came to pass and today the couple has six children— five girls and one boy. Their children are aged 16, 13, 10, seven, five and two years.

The first three pregnancies were smooth for Mullen, but for the fourth pregnancy she encountered some challenges. "I was on family planning and started bleeding. I decided to go to hospital. The doctor told me I had lost a pregnancy. Remember that I had lost my third born child some nine months back and now I was being told I had lost a pregnancy, which I was not aware of. The doctor advised me to go to Metropolitan Hospital in Buruburu to have all the remains in my womb removed," says Mullen.

"My husband looked at me and asked whether I had faith and I said 'yes'. He requested we go home and he prayed for me. After six months, I delivered a beautiful baby girl whom we named Ushindi Praise for she was our victory of praise. I also conceived my fifth baby while I was on family planning, but since I was taking some drugs for

TB, I had been informed that they would tamper with the family planning. With the last born child, I only knew that I was pregnant while on a mission in Congo and Botswana," she explains.

### Journey of love, prayers and patience

The parenting journey has not been without challenges, but not anything that is insurmountable. "Each child is unique. They portray different talents, but we don't make comparisons. We love them equally since all of them need our attention," she says.

Mullen and Pastor James serve as missionaries in the Southern part of Africa, at Destiny Chapel under Bishop Joel Chola and Pastor James Okumu.

She recalls how they met years ago at a fellowship in which James was pastoring. "It was called Climax Fellowship. That is where our journey of friendship began and later companionship," says Mullen.

She adds: "I loved the way he was relating to people. He had a big heart to accommodate everyone in the fellowship, yet he was a guest. Another unique thing I loved about him was that on that particular day, his mum died and he was coming from the morgue to preach to us. I told myself this is surely a man after God's heart and if he loved God like this, what about his family?"

For Pastor James, he says God revealed to him that Mullen would be his wife. "After the fellowship, she went back to school while I went back to business and preaching. Later on, I got engaged to a black American woman. One day, I had a dream in which I saw Mullen pregnant with my child. From

that point I changed my mind about getting married to the other woman. And as they say, the rest is history," James explains.

"We did not have money for a big wedding. We just went to the pastor. He told us if we didn't have money, he would still bless our marriage. And that is what happened," says James. The two will be celebrating their 17th anniversary this year.

Just like any other couple, they have faced challenges, but managed to work it through. "My husband loves his phone and spends most of his time on it if he is not conducting Bible Study. It took me time to adjust to that. Also, when we travel and go for missions, we always miss our children so much," says Mullen.

For the Magak's, God has always been the anchor and pillar of their marriage. James offers: "The secret to a long and fulfilling marriage is for husbands to love their wives just as Christ loved the church. If men can do that, then women will not submit. Also, you can only love if you have the source of love who is God. Marriage is a ministry. We minister to one another. It's a two way thing."

### Balancing act

As a family, they love spending time together by going out on dates with the children, especially when they have closed school.

"We take some time off from mission and just give the children a treat. They are our biggest treasure and they know when it's not mission time, it's family time - eating nyama choma and pizza, going out for a swim or a road trip," says Mullen.

Mullen shares how she has learnt to balance between motherhood and other roles she plays well. "I play my motherhood and wife roles as required. I always have time for myself because I need to be me. If I don't spare some time, I don't think I can handle the children and my husband well," she says.

To couples and parents, especially in this era when marriages do not last and the marriage institution has been shunned by many young people, they have a word of advice.

"Let God be the foundation of your marriage. The day you remove Him from your marriage, it will die. Just like the three-legged African stool that needs each leg for it to be stable; there is need for husband and wife to connect with God in everything they do. The husband is the vision of the family while the wife is the helper of the vision and God is the source of the vision. Communication is important in a marriage and if couples adhere to this, they will have a good marriage," she says in conclusion.

## Should you stay in an unhappy marriage for the sake of your children?

Some years back, I used to argue that its foolhardy for anyone to stick in an unhappy marriage because of children. I would make arguments such as, "You deserve to be happy", "Children will eventually leave," "You should not sacrifice your life because of children, walk out of the unhappy marriage." I would castigate such people, especially the women, as being unreasonable and foolish.

But having been married for over

a decade, I now fully understand and my view is different. Having developed that close bond with children for these years, it is difficult to leave the children behind or deprive them of one of the parents. It is not a simple rational decision and matters of the heart cannot be rationalised.

Recently, I have seen people getting divorced or separated after 30 plus years in marriage. I used to wonder why, but now I know better.

Such people, especially women, stuck in unhappy marriages to allow their children to complete their education and once they were out of their home, there was no more reason to stick in the unhappy marriage. The main reason that lead them to stay is no longer valid and they can freely express their opinions and their children who are adults would fully understand their decision.

But should you stick in unhappy

and abusive marriage just because of your children? This is not a simple answer, as matters of the heart cannot be argued logically. It's not a straight yes or no answer, there are many variations at play. I think this is a personal decision that one would need to make depending on your situation.

If the marriage is physically abusive, should you still stick along? I don't think so. Your life and that of your children will be in great danger.

You may be maimed or even killed by the abusive spouse.

Is there a threshold, which when passed, it means you can leave your marriage irrespective of the impact on your children? I don't know. You will have to do your own self-evaluation and make the right decision, in some cases - hanging on there might be the better decision to make.

## Sexual violence survivor turns her pain into power

After surviving attempted rape when she was only five years old, **Pendo Jolline** now fights sexual gender-based violence, be it in her profession as an advocate or through her music as a gospel artiste

**J**olline Katama, popularly known as Pendo Jolline in the gospel music circles is an advocate of the High Court of Kenya with special interests in Sexual Gender Based Violence and Child protection. She is a pastor and gospel artiste, an owner of a Gospel Recording Label- Custodian Music and a model. She has received honorary recognitions by international Nongovernmental Organisations (NGO) and universities as one of the artistes advocating against gender based violence through music. She was nominated for the Annual Pwani Golden Awards 2021. She is also a TV host at Chadi TV.

Under her recording label, she has released songs such as *Usifiwe*, *Jomba* and *Godfidence*, which have earned her a lot of popularity in the industry.

Her brother Kitole Kenda, also a Kenyan renowned entertainer and entrepreneur based in Europe has played a huge role in her music career and fashion interests as the younger sister also models for his clothing line — Kenda Apparels, amongst others.

### Unforgettable errand

And as Kitole shares, Jolline is the second born in a family of four originally from Mtwapa, Kilifi County. Born to their father Manasseh Katama a businessman and mother Dr Christine Kasichana, a doctorate holder in food Science.

"We grew up in Mtwapa, we spent our early years in a middle-class estate in the Kenya Agricultural Research Institute (Kari) now Kenya Agriculture and Livestock Research Organisation (KALRO) headquarters, later moving into the then developing ghetto neighbourhood Mikanjuni on our own piece of land and slowly built our privately owned home/house. This change was not easy at all, to say the least," shares Kitole about their childhood.

As a child, Jolline was quiet and kept to herself. However, she was active and cheerful when around people she knew... until something happened that made her build a wall around herself and become rebellious for some time. When she was about five years of age, their mother had sent them to the shop, which was a distance from their home. The road to the shop passed through an abandoned house in the middle of a mini-forest. As children, these trips also involved other personal errands—while Kitole rode his tyre, he left his sister behind who was also picking grass

to make herself a doll. While she was at it, a group of about five men approached and grabbed her and attempted to rape her. While Kitole had gone a long distance, he noticed that his sister was not behind him and decided to go back for her— he found the men right in the middle of their dirty business. They dropped her and ran away and he carried her home.

### Voice of reason

This is an experience that traumatised Jolline for a long time, and it is just one of the attempted rape cases that she survived. This opened her eyes to the societal rot called rape and sexual gender-based violence and she made it a lifetime goal to fight for victims of Sexual Gender Based Violence and also fight for children's protection.

The 30-year-old gospel musician attended SOS Kindergarten, Nyali before joining Ganjoni Primary School, Mombasa for her primary education. She later joined Murray Girls High School, Taita Taveta and transferred to Mtwapa Elite Academy where she sat her Kenya Certificate of Secondary Education exams before joining the

University of Nairobi as a law student. "She was a joyful child. Her musical journey started in church... singing in Seventh-day Adventist and Methodist churches at the age of eight. It is our mum who helped nurture her talent forcing her to sing in church and threaten her if she didn't. Later, her talent was nurtured through music classes, grandma and I," shares Kitole.

As her big brother and also a top musician, Kitole taught her the art of song writing and being the fast learner that she is, she picked up the pieces, put them together and created her own style.

Her breakthrough song as he shares was *Usifiwe* and *Jomba*. The songs received massive airplay on mainstream media, especially on Sunday. *Jomba* received recognition by NGOs such as Power Action Changers and Rotary Club, and University of Nairobi in collaboration with UN Women, as a song for advocacy against gender-based violence.

"What makes her songs unique is that she does her gospel music pouring all her soul, skills, experience, truth and the Word, a rare combination to be found in this generation. She creates her music through tunes straight from her head rather than writing down the lyrics... she just sings, hums and fills up line after line as she goes till the song is done. Sometimes she uses musical instrument and sometimes, she doesn't. Jolline arranges her music

chord by chord while playing her base guitar as she goes along. My favourite song from is *Faith is all I have*," shares the proud brother.

### Guilty pleasures

Her strongest trait as he shares is her courage and focus. She is focused to a fault and she can stand up to anyone, no matter what size or what position in society they hold.

"I think this is useful in her law and advocacy career as well as entertainment. This inspires me as a person as well. I have always felt that I should be a better example as a first born, from a young age. This has kept me going, when I see my siblings doing good for themselves," he intimates.

When she is not busy with her work, you will catch her playing bass guitar and singing or reading books, in her case it is mostly the Bible. Unlike many models that have turned most finger foods to takeouts, Kitole intimates that her sister's guilty pleasure is actually snacking, junk food, and her favourite meal being hot honey glazed chicken and guacamole. Her petite body is simply God given.

For Jolline, there is no telling where she will be in the next five years.

"I can't really tell. All I can say is that she is self driven and focused to a fault. So the future is definitely limitless for her. Great untold things lie underway in wait for her," he says.

## The mystic moon and its energies

At the sight of this heavenly body, Muslims marked the end of the Holy month of Ramadhan. This shows that the cyclic body holds a lot of religious significance. Astrologers, healers and some faithfuls believe in its potent and powerful power

Muslims all over the world marked the end of the holy month of Ramadhan after the sighting of the moon. The crescent moon holds a lot of religious significance for the Muslim community all over the world. It denotes the start and the end of the month of Ramadhan, the holy month of prayer and fasting. "The Islamic calendar is based on Lunar cycle. Each month lasts for a full lunation, which is the time span from one New Moon to the next. Traditionally, this is based on actual observation of the crescent (hilal) marking the end of the previous lunar cycle. Each month can have 29 or 30 days depending on the visibility of the moon, astronomical positioning of the earth and weather conditions," shares Mwanaidi Mohammed, an Islam teacher.

### Great significance

Female Ustadh, Fatma Ahmed shares that the moon is an important feature in Islam spiritual practices since the passing on of their Prophet, Mohammed. "The moon is significant to all of us human, but for us Muslims we observe the moon for 12 months as we go through the year. The Islamic calendar started three months after the death of the prophet. Before then, it was all just the observation of the moon. All our events follow the same. It is significant for recording of these events; we start fasting and end when the moon appears. Then there are three days in a month for fasting, we call them the white days, which also

have to align with the moon. On the 15<sup>th</sup> day of the cycle when the moon is on its fullest, it's known that it holds a lot of tragedies. People are in the hottest of moods and are angered easily, so at the beginning of the month we pray so that the month can be peaceful and holds blessings," shares the Ustadh.

The spiritual meaning of the moon can vary. The Quran includes a chapter titled the "The Moon," in which the split or crescent moon is a harbinger of the day of judgment. Moreover, the moon is associated with Muhammad in Muslim poetry, and the mystical tradition known as sufism uses the moon as a symbol of the heart responsive to the light of truth.

As Mijikenda elder John Baya shares, the moon holds a lot of mysticism culturally as well and it all varies between the different communities and their interactions. "The moon has been perceived spiritually as the source of mystic powers. First at the coast, the moon is known to have certain powers that affect the ocean. It is also believed that the moon phases affect people with mental issues. The crescent moon, especially influences mental status of those who are mentally unstable," he shares.

He says the moon is said to hold some divine powers. "One of these is its healing powers; this is why some of the diviners will wait for when the moon is full so they can hold their cultural activities. The moon itself is associated with the powers to sort out spirits. This creates a clarification between the spirits that move during the night, the spirits which move in darkness and those that move in the moon

light," shares the elder.

On the other hand, Pastor T Mwangi of Life Church Limuru, shares that before Abraham (a man who came to be known as the friend of God and father of nations) was called by God, he too came from a lineage of moon worshippers. Abraham was born and raised in Ur of the Chaldees, which is in modern Iraq, near Nasiriyah in the southeastern part of the country. This was an ancient city that flourished until about 300 BC. The great ziggurat of Ur was built by Ur-Nammu around 2100 BC and was dedicated to Nanna, the moon god.

### Moon worship

The moon was worshipped as the power that controlled the heavens and the life cycle on earth. To the Chaldeans, the phases of the moon represented the natural cycle of birth, growth, decay, and death and also set the measurement of their yearly calendar. Among the pantheon of Mesopotamian gods, Nanna was supreme, because he was the source of fertility for crops, herds, and families. Prayers and offerings were offered to the moon to invoke its blessing. "The calendar that was used then has a similarity to what the Jews, Greeks and even Muslims use today, the Lunar calendar, which revolves around the cycle of the moon. The calendar we have today with the days of the weeks are Roman in nature, and all fall under the Lunar calendar. So, astrology and study of heavenly bodies is real, but this intelligence is not biblical in nature, it is divination which we don't project, but we don't ignore its existence," shares Pastor T.

Ancient literature and in the realm of histories, show men as 'Stars' and other heavenly bodies. That is why Jesus is called 'The Bright Morning Star.' This is a kind of ranking in the realm of spirits. "In the spiritual realm, witches use the moon to cause witchcraft. It makes it possible for them to release demons, and also to interfere with people's destinies. I have also heard about the rise of madness cases during some phases of the moon. The word 'Lunatic' (a possession by spirit of madness) comes from the word 'Lunar,'" he says.

## How TB influenced Victorian fashion

Before influencers and advertisements, fashion relied on other factors to steer trends — including deadly diseases. One of the oldest diseases in human history, tuberculosis has had lasting impacts on the world. But it also had an unexpected influence on Victorian fashion when people began to romanticise it.

When tuberculosis began to spread with fervor during the Victorian era, the way it was contracted still wasn't fully understood. It became an epidemic and heavily impacted life in Europe and North America. During this time, it killed nearly one in five people, and around 40 per cent of deaths in heavily populated cities were caused by the disease.

It was often called "consumption" because of how much weight those inflicted with tuberculosis lost. Another nickname was "the white plague" because of how pale people would become. And yet, its final nickname was "the romantic disease." People became enamored with the physical effects of contracting the illness. Pale skin, thin waists, and flushed lips and cheeks from long-term fevers were seen as quite desirable!

As the disease took hold further, scientists began to understand germ theory and transmission. More women were getting sick than men, and they began to realise that it wasn't sanitary to have long trains flowing behind them and dragging through the spit-covered streets. So, gowns shortened and lost their trains. This made it so that shoes were more visible, making their appearance more important.

Though thin waists became popular and women that were ill got slimmer, people realised that emulating the look with restrictive lung-squishing boned corsets was not the most comfortable option when tuberculosis caused rough bouts of coughing. That led to dresses that were cinched at the waist to allow for a slimming effect without the tight pressure.

Voluminous skirts that gave the appearance of a slimmer waist became popular, too. The light fabrics gave way to thicker and sturdier materials. Consumption made the women who were ill appear much weaker and more subdued, and fashion leaned back toward the puritanical to emulate this. Those who were not sick powdered their face to appear pale, rouged their cheeks, and wore dresses that pulled their posture into a fragile and unsteady state.



Imali is the current national holder with a time of 11.77 which she clocked in March during the National Police Service Championships.



Manchester United stroll takes sting out of fan protest against Glazers

Manchester United took the sting out of their fans' latest protest against the Glazer family as they eased to a 3-0 win against Brentford on Monday. Ahead of a summer of change for troubled United, Ralf Rangnick's side won for just the second time in seven games to keep the atmosphere from turning toxic at Old Trafford.

Bruno Fernandes struck early in the first half and Cristiano Ronaldo (pictured) converted a second half penalty before France defender Raphael Varane bagged his first goal for United.

Despite winning their last home game of the season, United remain in sixth place in the Premier League with two games left.

They sit five points adrift of the top four with no realistic hope of qualifying for next season's Champions League.

Fittingly, it was under grey, rain-filled skies that fans protested against despised owners the Glazers for a third successive home match.

**Offensive chants**

Outside the stadium before kick-off, a group of supporters held up anti-Glazer banners, set off red smoke bombs and made offensive chants about the club's owners.

United fans had been urged by the protesters to leave the stadium with 17 minutes left in the match -- one minute for every year the United States-based Glazers have owned the club.

But that idea proved a damp squib as only a handful left their seats.

There were more empty seats by the time United embarked on a post-match lap of appreciation, but no overt signs of dissent

towards their underachieving stars.

"In possession that was one of our best performances this year. It was the type of performance we wanted to show to our supporters," Rangnick said.

Regardless, there is no doubting the overall level of frustration at another trophyless season for United, who haven't won the Premier League since 2013 and last lifted a major trophy five years ago.

Aside from a few scathing comments about the club's direction, Rangnick has done little to jolt United out of their malaise since replacing the sacked Ole Gunnar Solskjaer in November.

"In the end I'm not happy with the results, especially in the last four or five weeks. In general we have lacked consistency," Rangnick said.

"It's obvious quite a few players will leave and there is a need for top quality players."

"Other clubs only needed two or three transfer windows to challenge. I strongly believe that if everyone works together we can bring Man Utd back to where we need to be."

Rangnick was in charge of his last home game as United interim manager before the recently-hired Erik ten Hag arrives from Ajax to start his rebuilding job next season. **-AFP**

"So let's continue it together," added the 2014 World Cup winner, who has made 112 appearances for Germany since his international debut in 2010. # Get set for Uhuru Classic

All preparations are complete for the inaugural Nairobi City Marathon to be run on the new Expressway on Sunday, President Kenyatta to flag off athletes who will battle for Sh6.9m winner's prize

Nairobi police traffic department has released an elaborate road closure diversions ahead of the inaugural Uhuru Classic Nairobi City Marathon as preparations for the race planned for Sunday moved a notch higher.

The affected roads are sections of Mombasa road, Uhuru Highway, Upper Hill and Forest road while within the CBD, Kenyatta Avenue, Muindi Mbingu and sections of Haile Selassie and University Way will also be closed.

Motorists from Mombasa road heading towards the CBD and Westlands have been advised to use the Southern Bypass or Likoni, Enterprise and Lusaka roads to avoid inconveniences on Uhuru Highway. Traffic to and out of the city will be diverted to alternative roads between 4am and 2pm.

### International standards

Athletics Kenya (AK) president Jackson Tuwei said the course has been certified to international standards so any record broken will be internationally recognised.

The start and finish line for the marathon will be at Nyayo Stadium with the 42km run winding through the Jomo Kenyatta International Airport, Central Business District, ABC Place in Westlands and will see the competitors cover 33km on the Nairobi Expressway and 9km on the rest of the normal city roads.

Tuwei said the full marathon race will start at the Nyayo Na-

tional Stadium from where athletes will snake through the Nairobi Expressway all the way to the Jomo Kenyatta International Airport turn-off.

The competitors will then exit the Nairobi Expressway and branch off to Haile Selassie Avenue towards the Cooperative House Roundabout before turning left to Moi Avenue.

They will then drop to City Hall Way around Kencom House, onto Taifa Road and then onto Harambee Avenue, Uhuru Highway and back to City Hall Way before they head to Kimathi Street.

The competitors will then turn left to Kenyatta Avenue, branch onto Koinange Street then turn left to Monrovia Street through Muindi Mbingu Street and back to Kenyatta Avenue.

They will then head to Moi Avenue, and run all the way to University Way roundabout, and back to University Way before hitting the Globe Cinema Roundabout onto Kipande road and Museum Hill roundabout.

### Prize money

They will then return to the Nairobi Expressway and run all the way to ABC Place at the junction of James Guchuru road, where they will turn and head to the finish at the Nyayo



### National Stadium.

The half marathon competitors will avoid the city centre by staying on the Nairobi Expressway. They will make turns at Ole Sereni Hotel, and at the ABC Westlands then head back to the finish at the Nyayo National Stadium.

The 10km racers will make turns at Capital Centre and Museum Hill, and turn back to the Nyayo National Stadium.

The organisers have set aside \$389,500 (about Sh44.8 million) as prize money for the Uhuru Classic out of which \$370,000 (Sh42.55m) will cater for prize money in men's and women's marathon races.

The men's and women's winner will each take home \$60,000 (Sh6.9m) in prize money with the second placed athletes in each of the categories pocketing \$35,000 (Sh4.02m).

Madrid had beaten Espanyol 4-0 on Saturday and the players were celebrating at Plaza Cibeles after an open-top bus had wound its way through the city to the statue where players and fans always toast their biggest trophies.

"And now to Wednesday, yes we can!" Ancelotti shouted at the adoring crowd, who chanted back "si, se puede!", "yes we can!"

Many had wondered whether celebrations were appropriate or sensible, given how they were sandwiched between the two mammoth games against City, especially after Pep Guardiola's side left Madrid needing to pull off another rescue act following the Spanish champions' 4-3 defeat in the first leg.

Beyond concerns about recovery or fatigue, there were suggestions that dwelling on a 35th Spanish league title might reduce, even subconsciously, some of the

need- and desperation to chase a 14th European Cup.

But Ancelotti was in no doubt that celebrations, with all the positivity and energy attached, would help, not hinder, Madrid's pursuit of another Champions League final.

"A celebration is good for the mental side of things," Ancelotti said. "We are professionals. Tonight we all celebrate together. Tomorrow we train and Wednesday we have another important match. If during the celebrations someone cuts their foot or a leg, okay, but that won't happen."

Madrid performed a similar routine before their sensational comeback against Paris Saint-Germain in the last 16. After thrashing Real Sociedad at the Santiago Bernabeu the Saturday before the return leg, Real Madrid's players walked back out onto the pitch long after the final whistle, to applaud and absorb the chants of the fans, who were urging the team to believe a comeback was possible.

Manchester City, though, are a different proposition to PSG, a more complete, astute and resolute team, who will be less vulnerable to the aura of Real Madrid in Europe and the gusts of momentum that seem to sweep through the Santiago Bernabeu on biggest European nights. -AFP
